1. The Artist gives permission to the Berea Arts Council (BAC) to exhibit and/or sell works of art or craft covered by this agreement. BAC will offer the artworks for sale at the retail price specified on the contract or inventory sheet. BAC will receive a 40% commission on all items sold in the BAC galleries.
2. The Artwork must be listed on this or any accompanying inventory sheet. The Artist hereby warrants that he/she created and possesses unencumbered title to the artwork, and that their descriptions are true and accurate. BAC reserves the right to refuse any or all work submitted for exhibition or sale.
3. The net proceeds from the sale (less 40% commission) of the Artworks shall be held in trust for the Artist. The Artist will be mailed a check within two weeks following the close of the exhibit.
4. Duration of show: Artworks are to remain in the Gallery for the duration of the exhibit. The Artist does not intend to request their return before the end of this term.
5. Transportation Responsibilities: Packing and shipping charges, insurance costs, other handling expenses and risk of loss or damage incurred in the delivery of Artworks from the Artist to BAC and their return is the responsibility of the Artist.
6. Responsibility for Loss or Damage, Insurance Coverage: BAC is responsible for the safekeeping of all Artworks while they are in its custody. The Berea Arts Council is responsible to the extent that our Bailee’s coverage provides. (A printed copy of the policy is available upon request.)
7. Promotion: BAC shall use its best efforts to promote the Artworks and agrees to provide adequate display of the Artworks. The Artist agrees to give ultimate control over the display or storage of the Artworks to BAC; any exception shall be agreed to by both parties.

8. **Reproduction:** The Artist reserves all rights to the reproduction of the Artworks except as noted in writing to the contrary. BAC may arrange to have the Artworks photographed for educational purposes, publicity or promotion, at its discretion. BAC will provide the Artist’s name and, if appropriate, the copyright, for each piece photographed. (See the ‘Photography Release’ rider below.)
